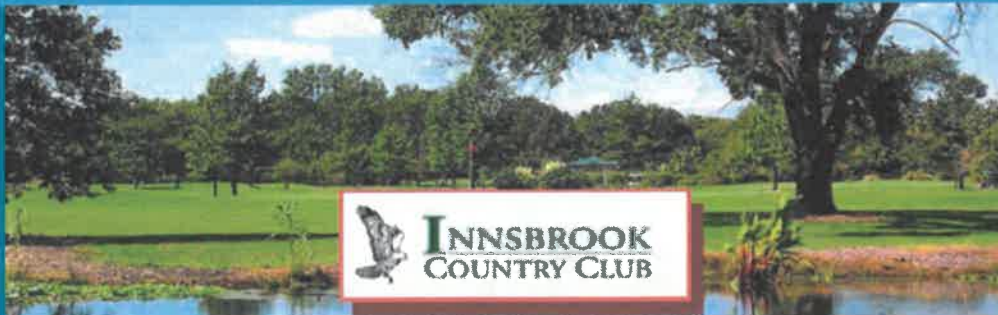

JUSTICE STEVEN DAVID (One hundred sixth Justice)

Justice David has enjoyed a multi-faceted career with private practice and corporate counsel experience, twenty-eight years of stellar military service and fifteen years as a trial court judge in Boone County. He graduated magna cum laude from Murray State University as a Distinguished Military Graduate on an R.O.T.C. scholarship. He earned his law degree from Indiana University's Robert H. McKinney School of Law. He is also a graduate of the Indiana Judicial College and the Graduate Program for Indiana Judges. Justice David is a member of many legal and civic organizations including the Indiana Judges Association, the state and national Council of Juvenile and Family Court Judges, the American Inns of Court and the American Bar Foundation. He is a member of the American, Indiana, Indianapolis, Boone County and Lake County Bar Associations as well as the Military Officers Association of America, the Zionsville American Legion, the Lebanon Elks Club and the Lebanon Kiwanis Club. He currently serves as President of the Community Foundation of Boone County and has previously served on both the Zionsville and Lebanon Boys and Girls Clubs' Board of Directors. He enjoys participating in marathons and triathlons, reading and golf. He has hiked the Grand Canyon three times. One hike included the Boone County Bar Association and another was a family hike.
